



Standardized ACFAS Division Support of Resident Poster/Manuscript Presenters at the 2016 ASC

1. ACFAS will send out a solicitation in advance of the ASC to all ACFAS Resident Members and all Residency Directors, making them aware of funds available from the Divisions, and laying out the process for support to be received.
2. The poster and/or manuscript must be accepted for presentation at ASC by ACFAS.
3. The resident must be a member in good standing with ACFAS.
4. To be considered for support, all residents must complete a standard application (see attached), and submit it to their Division President. A listing of the Divisions, their geographies, and their webpages can be found at <http://www.acfas.org/Physicians/Content.aspx?id=455>
5. Posters or manuscripts must be displayed/presented at the 2016 ASC.
6. An electronic version of the poster must be provided to ACFAS for posting on the Division website.
7. If a resident's poster/manuscript is accepted for Division funding support, the author(s) are expected to attend the conference as well as their Division's Membership Meeting at the conference.
8. Standard amount to be provided by all Divisions:

Poster submitters: \$250.00
Manuscript submitters: \$500.00

The actual number of awards may vary by Division, year to year, and will be determined on an annual basis.

9. The application process will occur in advance of the ASC; the provision of funding will occur at or after the ASC, once all requirements have been met.
